This form is used to support applications for faith-based admissions to the Madani Boys School | Madani Girls School in the academic year 2026-27.

Applications to start Year 7 when moving from primary to secondary school	Applications for admission to other year groups and for mid-year admissions
Parents / carers wishing their children to be considered under the faith-based oversubscription criteria must return this form to the relevant school by 4pm Friday 31st October 2025 (reception closes at 4pm). <i>Parents / carers <u>must also</u> complete the Common Application Form for admission to Year 7 and return it to the local authority for the area in which they live by Friday 31st October 2025.</i>	Parents / carers wishing their children to be considered under the faith-based oversubscription criteria must return this form to the relevant school at the time of making their application. Applications will be considered individually as they are received.

In all cases, the form must be signed by a parent / carer. To support the application, it may also be countersigned by an official Imam who knows the family and / or the headteacher of a properly constituted madrasah the child attends. If the family's circumstances mean that an official Imam is not available, please contact the school. It is the responsibility of the parent / carer to arrange for the form to be countersigned and returned on time.

The first page of the form asks for the child's details so we can match them to an application made on a Common Application Form. We ask for additional information to ensure we apply the oversubscription criteria accurately. We also ask for contact details for a parent / carer so we can communicate with the parent / carer easily. Definitions of the terms used in the form can be found in the latest **Admissions Arrangements** for each school.

The rest of the form is a Religious Practice Check. *The Religious Practice Check is to assure the school that, for admissions under the criteria for faith-based admissions, a child is being brought up as a practising Muslim. Practising the Islamic faith has many elements, and the check is designed to take a broad range of these elements into account.* It asks parents / carers to indicate the elements of Islamic faith the family practises.

The Religious Practise Check is comprised of 3 sections with a maximum score total of 15:

- Section 1 – To be completed by the Parent / Carer (Maximum score total 11)
- Section 2 – To be completed by an Imam (Maximum score total 2)
- Section 3 - To be completed by the Headteacher / Principal of a properly constituted Madrasah (Maximum score total 2)

*The answers in each section contribute to a score which is then totalled. In the event that there are more applications for Islamic faith admissions than available places (under Oversubscription criteria b, c or d), those children with the highest scores in the religious practice check will have priority. Please ensure you refer to the **Admissions Arrangements** for each school.*
